## **Session**

That was followed by a session on the freedom of speech by **Barrister Ali Tahir**, a socio-political analyst and International Law expert. Delegates were apprised of relevant legal terms such as libel, slander, and defamation. Barrister Tahir shared his concernsregarding the exploitation of the cyberspace and urged delegates to prudently verify thesource and content of the information received.



## **Session**

Before concluding day 1, an ice-breaking activity was arranged which required delegates to state one fact about their home country for the other delegates to guess. The activity allowed delegates to learn new information and revel in the undeniable diversity.





## **Cultural Performances**

Dressed up in their formal attire, the delegates reported to the Lotus Ballroom after swiftly having their morning coffee and breakfast. The session opened with two charming performances: one, an instrumental performance by the *Thai-Chinese International School*, and the other, a traditional Thai dance by female students.



After a couple of key-note speeches made by the Chairman and Vice-Chairman of MAPS regarding the take-aways from the previous day, the moderator for the day, **Mr. Eric McGriff** from *USA* introduced the three honourable ambassadors: **H.E Mr. Fakhriddin Sultanov** (*Consul-General of Uzbekistan to the Kingdom of Thailand*), **H.E Mr. Yasir Hussain** (*Deputy Head of Mission of Pakistan to Kingdom of Thailand*), and **H.E Ms. Atiffa Yousaf zai**, *Assistant Director of Youth Affairs KPK-PAK*.



#### **Panel Session**

The following arguments and questions were answered during this panel session:

- Should political happenings be intervened by the youth or be left in the hands of the Political leaders?
- Could social media be used as an exploitative tool targeted at the youth of today?
- What individual or collective steps could the international community take to eradicate food insecurity and malnutrition in war-torn states?
- How could entrepreneurial settings and access to basic resources be put in place for the Youth in this globalized world?







## **Gifts To Panelists**

The delegates posed their questions to the panelists, and soon afterwards the three dignitaries were gifted with medals as a token of appreciation.



### **MUN Simulation**

After a brief coffee break, the delegates were grouped into three teams, with each focusing on one of the three themes: climate change, human trafficking, and violent extremism. The three teams went into two unmoderated caucuses to come up with 5 resolutions.



#### The team for climate change presented the following mainstream solutions:

- To restore enviornment with judicious use of renewable and sustainable energy Resources.
- To reduce sources of carbon emission such as SUP's.
- To encourage the local participants and women to participate in climate adaptation training programs.
- To focus on technological advancement for climate prediction and advocating Digital movement for climate literacy.
- To uhold the principle of eual but differentiated responsibility (carbon trade-off)



- The team against human trafficking activists presented the following resolutions:
  - 1) Empowerment of migrant workers
  - 2) Incusive and accessible education(rights/liberties, vocational training etc.)
  - 3) Strengthening multi-lateral frameworks and policies.
  - 4) Safe houses/ havens/ protection for victims.
  - 5) Cracking down on sources (Dark web, Social networks, Mafia etc.)



#### The team against violent extremism presented the following resolutions:

- Since education plays a crucial role in peacebuilding, we should integrate more holistic approaches that are inclusive and sensitive to extremism.
- Bottom-up approach is called upon to involve people on 'grass root' leves to maximize the impact of eradication of extremism with social movements.
- Multi-track diplomacy should be adopted to involve individuals, societies, regions and global communities.
- Through social media, public opinion on extremism should be moderated with more responsible, reliable and verified information promoted with healthy and peaceful messages.
- Latent and active conflicts should be solved with reconciliation to address the roots of extremism to Build trust and live cooperatively.



The day concluded with closing remarks by **Selina Haddad** (*Qatar*), followed by dinner and **group photographs**.



## **The World's Cultures**

Donning their cultural outfits, the delegates now offered a glimpse into their vibrant and rich roots. The first speech of the day was given by **Mr. Muhammad Ahmad**, *Vice Chairman MAPS* regarding the fellowship reviews and further details into MAPS' initiatives.
